Rules for Invited Speakers

1. Invited speakers can submit both abstract or full-text manuscripts
2. Abstracts should not have subsections and not exceed 600 words. Also, abstracts should include a title, authors' first and last name (first letters capitalized, affiliation, title, an email address, and the abstract). A maximum of 15 references are allowed.
3. Both abstracts and full-texts should be in Microsoft Word format (.docx) and A4 size (21cm x 29.7cm) with 2.5cm margins from the right and left.
4. All manuscripts should be written with Times New Roman font and 12pt font in single spacing and with a single blank line between paragraphs.
5. Full-text manuscripts should include; a title, authors' first and last name (first letters capitalized, affiliation, title, an email address, and the abstract). The maximum word count should be 3000 without references, and there should be a maximum of 30 references.
6. Authors are responsible for the regular spelling and grammar of their texts.
7. Figures, pictures, tables, and graphics should be in the relevant place among the word document with appropriate numbering. All figures, pictures, tables, and graphics should be quoted at the end of the relevant sentence. All abbreviations should be explained in footnotes. If any of the figures, pictures, tables, and graphics are used from another source, appropriate permissions should be obtained by the author.
8. Abbreviations should be given in parenthesis where they were first mentioned, and the same abbreviation should be used in the entire text.
9. References should be numbered in superscripts. Within the references with six or fewer authors, all names will be written. If there are more than six authors, then only the first three authors' names should be given with following "et al.". Abbreviations of journal names should be used as in Index Medicus format. Articles that are still in a review should not be used as references but can be mentioned in the text. Personal opinions can be used as references only with information containing name, date, and communication type (email address if applicable).
